Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000	Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector. In 2023-24, the Council made payments totalling £500 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Aberaeron Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of Qualification

#### Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 4. The Council has not published its notice of audit and therefore I am unable to determine whether or not proper arrangements were made for the exercise of electors rights under the Public Audit (Wales) Act 2004.

### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.


### Publication of documents

The Council is required to publish certain documents electronically by the Democracy and Boundary Commission Cymru etc. Act 2013 and the Local Government and Elections (Wales) Act 2021. The Accounts and Audit (Wales) Regulations 2014 require the Council to publish its Annual Governance Statement and the Auditor General's audit certificate and report alongside its annual accounts.

My examination of the Council's website identified that the Council only publishes the Accounting Statement page of the Annual Return. It must publish all pages including the Auditor General's report.

We recommend that the Council reviews its publication arrangements to ensure that it properly meets its statutory duty.

There are no further matters I wish to draw to the Council's attention.


